Participants agree to be bound by these terms and conditions (the "Terms and Conditions").

The Promoter

Promotion Period

2. The Promotion will commence at 00:00 (GMT) on 26 January 2012 and shall close at 00:00 (GMT) on 27 March 2012 (the "Promotion Period").

Offer

3. Participants who purchase a new (i.e. not second hand or reconditioned) Samsung printer (models: CLP-325W, SCX-3405FW, SCX-4729FW, SCX-3405W, ML 2955DW, SF-760P) (each a Promotion Product) and together "the Promotion Products") from UK or ROI participating retailers (whether purchase is made in-store or online) within the Promotion Period will be entitled to a receive a cash credit of £50/€50, £30/€30 or £20/€20 payable by cheque.
